4.1. Description of first aid measures


Skin contact

Eye contact

Upon irritation of the eye: Remove contact lenses. Flush eyes with plenty of water or salt water (20-30°C) for at least 15 minutes and continue until irritation stops. Make sure you flush under the upper and lower eyelids. Seek medical assistance immediately and continue flushing during transport.





Ingestion

In the case of ingestion, contact a doctor immediately. If the person is conscious, give them water. DO NOT try to induce vomiting, unless this is recommended by a doctor. Hold head facing down to prevent vomit returning mouth and throat. Prevent shock by keeping the injured person warm and calm. Initiate immediate resuscitation if breathing stops. If unconscious, roll the injured person into recovery position. Call an ambulance.

4.2. Most important symptoms and effects, both acute and delayed


